### Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B** (read as **ACUITE B**) and short term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs. 14.00 crore bank facilities of Tubas Wire & Conductor Private Limited. This rating is now an indicative rating and is based on best available information.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

#### About the Rated Entity:

Tubas Wire & Conductor Private Limited (Tubas), incorporated in 1989 is a Mumbai-based company engaged in the manufacture of aluminium conductors, wires, strips among others. The manufacturing unit is located at Daman.

For FY2014-15, Tubas reported profit after tax (PAT) of Rs. (0.06) cr on operating income of Rs.22.45 cr as against PAT of Rs.0.18 cr on operating income of Rs.27.78 cr in FY2013-14. The tangible net worth stood at Rs.3.14 cr in FY2014-15 against Rs.3.25 cr in the previous year..
