Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs. 8.00 crore bank facilities of The Suites Hospitality Private Limited. The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

The Suites Hospitality Private Limited (TSHPL) was incorporated on 19h June 2013 promoted by Mr. Vishal Bhardwaj & Mrs. Ritu Bhardwaj. The Suites Hospitality Private Limited will be engaged in running of 3 Star Hotel in Shirdi, Maharashtra.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
