Acuite has reviewed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 15.00 crore bank facilities of Hare Krishna Orchid. This rating is now an indicative rating and is based on best available information.

HKO has undertaken the construction of Hare Krishna Orchid Block B (Phase I, II and III) ' a residential project in Mathura, Uttar Pradesh at an estimated cost of Rs.67.70 crore. The project, launched in January 2014, has completed around 50 percent of the construction work already and registered bookings for 188 units out of the total 720 envisaged. While Phase I of the project is expected to be completed by December 2016, work on Phase II and III is estimated to get over by December 2020.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
