Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 11.50 crore bank facilities of Shyam Hatcheries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shyam Hatcheries, established in 2007, is a Haryana-based partnership firm engaged in the breeding and selling of broiler birds. Mr. Krishan Kumar and Mr. Bijender Singh, the partners possess more than two decades of experience in the said line of business. The firm procures parent chicks from Venkateshwara Hatcheries Private limited. For FY2014-15, the firm reported profit after tax (PAT) of Rs.0.16 crore on operating income of Rs.17.85 crore as compared to PAT of Rs.0.12 crore on operating income of Rs.16.33 crore in the previous year. The net worth stood at Rs. 4.71 crore as on 31 March, 2015 compared to Rs. 4.21 crore in the previous year.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
