Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A4**) on the Rs. 5.50 crore bank facilities of Vam infrastructure Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:
