### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 23.96 crore bank facilities of SBM Traansport Applications Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

### About the Company

Incorporated in 2012, SBM is a Chennai-based company that provides transportation services for the automobile sector. The day-to-day operations are managed by Mr. M. Selvaraja and Mr. Palaniandi Raja (Directors). For FY2014-15, the company reported net loss of Rs.0.01 cr on total revenue of Rs.8.00 cr as against net loss of Rs.0.10 cr on total revenue of Rs.2.06 cr in FY2013-14.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
