Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 13.00 crore bank facilities of Sai Pet Preforms. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

About the Rated Entity:

The Bangalore-based Sai Pet Preforms (SPP), was established in 2012 by Mr. P. S. Santosh Nag, Partner. The firm is engaged in the manufacture of PET preforms and plans to set up a windmill at Anantapur, Andhra Pradesh.

For FY2014-15, SPP reported net loss of Rs.0.24 cr on operating income of Rs.4.84 cr, as compared with net loss of Rs.0.17 cr on operating income of Rs.1.90 cr in FY2013-14. The net worth stood at Rs.5.81 cr as on March 31, 2015, as compared with Rs. 3.38 cr a year earlier.
