Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 5.67 crore bank facilities of Shree Balaji Industries on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Mumbai based Shree Balaji Industries was incorporated in 2012 by Mr. Sushil Kumar Khetan, Mr. Sanjay Kumar Aggarwal, Mr. Hari Om Gupta and Mr. Ashok Kumar Aggarwal. The firm is engaged in the manufacture and processing of Gaur gum and Churi (cattle feed).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
