Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) on the Rs. 9.16 crore bank facilities of Almed Laboratories Private Limited (ALPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Almed Laboratories Private Limited was incorporated in 2005 and commenced operations in 2006. The company is led by Mr. Mukand Swarup and Mr. Dinesh Kumar Swarup and is engaged in the manufacture of plastic packaging containers for the dairy industry. The manufacturing unit is located at Sirmour, Himanchal Pradesh. The installed capacity stands at 50 lakh cups/month for FY2014- 15.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
