Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs.6.32 crore bank facilities of Gati Motors Private Limited (GMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Gati Motors Private Limited (GMPL) was incorporated in the year 2007 and started commercial operation in 2008 by Late Mr. Ajit Kumar Banerjee and son Mr. Partho Priya Banerjee. It's an authorized dealer of Tata Motors Limited engaged in selling and providing servicing to light and intermediate commercial Vehicle. It's having four showrooms with workshops facility in, Burdwan and Birbhum district of West Bengal. The registered office of the company is in Durgapur.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
