Acuité has reviewed the long term rating of '**ACUITE B+**' (**read as ACUITE B Plus**) on the Rs.106.50 crore bank facilities of Shanti Devi Charitable Trust. This rating is now an indicative rating and is based on best available information

SDCT, registered as a public charitable society in 2006 has undertaken a Greenfield project to set up a medical college. The proposed a 700~bed hospital 'N C Medical College' has a sanctioned intake capacity of 150 students per year. For FY2014-15, SDCT reported net loss of Rs.2.14 cr on operating income of Rs.9.52 cr as compared to net profit of Rs.1.25 cr on operating income of Rs.9.05 cr in FY2013-14. The net worth stood at Rs.53.21 cr as on March 31, 2015, as against Rs. 68.95 cr a year earlier.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
