Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE C**’ (read as **ACUITE C**) from ‘**ACUITE B-**’ (read as **ACUITE B minus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 19.00 crore bank facilities of Nair Coal Services Private Limited (NCSPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

The downgrade is based on the CIC report which reflects that there were delays in Auto loan for 24 days in February 2025 and 27 days in March 2025.

About the Company

Nair Coal Services Private Limited (NCSPL), incorporated in 1984, is a Nagpur-based company promoted by Mr. Susheel Nair (Director). The company is engaged in liaison and supervising of logistics of coal. NCSPL operates through its nine branches across India.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuité endeavoured to gather information about the entity/industry
