#### Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 31.00 crore bank facilities of Orient Steel And Industries Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Orient Steel And Industries Limited, established in 1957, manufactures steel casting (used in rail wagons), CR strips, LHB coaches, sheet piles used in irrigation projects for dredging in dams and soil retention. The manufacturing facilities are located in West Bengal and Haryana. The director are Mr. Nilesh Rajgharia, Mrs. Shuchi Rajgharia and Mr. Nawal Kishore Rajgharia having an experience of more than four decades in iron and steel industry.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
