Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 33.50 crore bank facilities of Sharda Timber Private Limited (STPL).. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Sharda Timber Private Limited (STPL), incorporated in 2013, is a Haryana-based company engaged in the trading of timber. The company procures timber from Singapore, New Zealand and Malaysia and sells the same across India. The manufacturing facilities are located at Gandhinagar, Gujarat. Mr. Vikas Goyal and Mr. Krishan Kumar Goyal, the promoters have around three decades of experience in the aforementioned line of business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
