SMERA has reviewed long-term rating of '**SMERA B-**' (**read as SMERA B minus**) and short term rating of '**SMERA A4**' (**read as 'SMERA A four'**) on the Rs. 7.51 crore bank facilities of Lubrina Recycling Private Limited. This rating is now an indicative rating and is based on best available information.

#### Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

#### About the Rated Entity

LRPL, incorporated in 2010, is a Kolkata based company promoted by Aashish Lohia. The company is engaged in the recycling of used oil ( lube based stock ) and waste industrial oil. It has an installed capacity of 9000 kilo liters per annum. The company has set up a processing unit in Kolkata (Bishnupur) at a cost of RFs.10.00 crore funded through a term loan of Rs.5.38 crore and promoters' funds of Rs.4.42 crore. The commercial operations commenced in Dec 2014.

For FY2014-15, LRPL reported a net loss of Rs.0.44 crore on operating income of Rs.0.21 crore. The company has registered operating income of Rs.1.35 crore for FY2016 ( from April to November).
