Rating Rationale

Acuite has reaffirmed the long-term rating of 'Acuite B-' (read as Acuite B minus) and the short-term rating of 'Acuite A4' (read as Acuite A four) on the Rs. 7.51 Crore bank facilities of Lubrina Recycling Private Limited (LRPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

LRPL, incorporated in 2010, is a Kolkata based company promoted by Aashish Lohia. The company is engaged in the recycling of used oil (lube based stock) and waste industrial oil. It has an installed capacity of 9000 kilo liters per annum. The company has set up a processing unit in Kolkata (Bishnupur) at a cost of Rs.10.00 crore funded through a term loan of Rs.5.38 crore and promoters' funds of Rs.4.42 crore. The commercial operations commenced in Dec 2014.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
