Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minusa) nd the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.51 Crore bank facilities of Lubrina Recycling Private Limited (LRPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Lubrina Recycling Private Limited, incorporated in 2010, is a Kolkata based company promoted by Aashish Lohia The company is engaged in the recycling of used oil (lube based stock) and waste industrial oil. It has an installed capacity of 9000 kilo liters per annum. The company has set up a processing unit in Kolkata (Bishnupur) at a cost of Rs.10.00 crore funded through a term loan of Rs.5.38 crore and promoters' funds of Rs.4.42 crore. The commercial operations commenced in Dec 2014.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
