Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B' (read as ACUITE B)** on the Rs. 9.50 crore bank facilities of Global Stainless. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Global Stainless (GS), established in 2011, is a Delhi-based partnership firm promoted by Mr. Mukesh Jindal and Mr. Pawan Khandelwal. The firm is engaged in the trading of iron and steel and is also an authorized dealer of Jindal Stainless Limited catering to the Delhi NCR region.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
