**Rating Rationale**

Acuite has downgraded the long-term rating to ‘ACUITE B-’ (read as ACUITE B minus) from ‘ACUITE B’ (read as ACUITE B) on the Rs. 6.00 crore bank facilities of Shri Om Rice Mills (SORM) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

The Uttar Pradesh-based, Shri Om Rice Mills was established in 1983 as a partnership firm by Mr. Mahesh Chand Agnihotri, Mr. Ram Naresh Agnihotri, and their family members. Shri Om Rice Mills (SORM) is engaged in the business of milling and processing of paddy into basmati and non-basmati rice.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
