Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minuso**) n the Rs. 12.00 crore bank facilities of Sri Venkateshwara Rice Industry. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Sri Venkateshwara Rice Industry, was established in 2007, is a Telangana based partnership firm engaged in the processing of rice at Suryapet. The installed capacity stands at 28,800 metric tonnes per annum. The firm was promoted by Mr. V. Laxmaiah and Mrs. V. Sridevi.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
