**The issuer did not co-operate; based on best available information.

Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BB+**' (**read as ACUITE double B plus**) and review the short term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs.12.00 crore bank facilities of J P Dyechem Private Limited (JPDPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

J P Dyechem Private Limited (JPDPL) incorporated in 1996, is a Mumbai (Maharashtra) based company engaged in trading of Chemicals. The company promoted by Jayendra Himatlal Doshi and Paras Arvind Dhami. JPDPL is engaged in trading of chemicals which used in various industries like textile, food, dyes, rubber, paint, ceramic fertilizer, soap, printing ink, petroleum, metallurgy, construction materials, pulp and paper industry, photographic and adhesive industries.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
