SMERA has reviewed long-term rating of 'SMERA BB-' (read as SMERA BB minus) on the Rs. 5.00 crore bank facilities of Om Drishian International Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity

Om Drishian International Limited (ODIL), established in 2008 is a New Delhi-based company promoted by Mr. Rakesh Bansal. The company is engaged in the trading of T-shirts, shirts, vests among others at East Delhi, Sahibabad, Ghaziabad.

For FY2014-15, ODIL reported (Profit after Tax) PAT of Rs.1.18 crore on operating income of Rs. 227.61 crore compared with PAT of Rs. 0.68 crore on operating income of Rs. 361.37 crore for FY2013-14. The net worth stood at Rs. 12.56 crore as on 31 March, 2015 as against Rs. 6.72 crore a year earlier.
