Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs.34.00 Cr. bank facilities of Sainath Autolinks Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sainath Autolinks Private Limited (SAPL) was incorporated on 16 April, 2010 by Mr. Mohan Chawla and Mr. Amarjeet Chawla. The company is engaged in the passenger vehicle business and is an authorised dealer of Maruti Suzuki. The company has three showrooms with workshop facility at Durgapur, Santiniketan and Purulia, West Bengal.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
