Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** and short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.13.00 Cr. bank facilities of Ma Mahamaya Rice Mill Private Limited (MMRMPL).The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Mahamaya Rice Mill Private Limited (MMRMPL), established in 2006, is a West Bengal based company engaged in processing of parboiled rice with an installed capacity of 74 tonnes per day. The overall operations are managed by Mr. Sandip Hazra.

Non-cooperation by the issuer/borrower:
