Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.79 crore bank facilities of P P Rice Mill Private Limited (PPRMPL). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

P.P Rice Mill was established in 2011 by Mr. Sourav Kumar Bodhak and family. The firm plans to set up a rice processing unit in West Bengal with capacity of 96 metric tons per day. Commercial Production was expected to commence from May 2016.
