Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minusa) nd the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.79 crore bank facilities of P P Rice Mill Private Limited (PPRMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information

About the Company

P P Rice Mill Private Limited (PPRMPL) was established in 2011 by Mr. Sourav Kumar Bodhak and family. The firm plans to set Up a rice processing unit in West Bengal with capacity of 96 metric tons per day. Commercial Production was expected to commence from May 2016.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
