Rating Rationale

Acuité has downgraded the long term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.03 crore bank facilities of Ensol Multiclean Equipments Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ensol Multiclean Equipments Private Limited, was incorporated in 2002, it is a Jaipur based private limited company promoted and managed by Mr. Arun Sharma. The company manufactures and assembles customized waste handling equipments such as garbage compactors and tippers mainly for the state government.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
