Acuité has reviewed long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.14.32 crore bank facilities of Associated Toolings (India) Private Limited. This rating is now an indicative rating and is based on best available information.

West Bengal-based, Associate Toolings (India) Private Limited (ATIPL), incorporated in 1985, is engaged in the manufacturing and export of industrial valves. The company is led by Mr. Udayan Karmakar.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
