**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and reaffirmed short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 14.32 crore bank facilities of Associated Toolings India Private Limited (ATIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

West Bengal-based, Associated Toolings India Private Limited (ATIPL), incorporated in 1985, is engaged in the manufacturing and export of industrial valves. The company is led by Mr. Udayan Karmakar.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-

cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
