Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.12.00 crore bank facilities of Impulse Pharma Private Limited (IPPL). This rating is now an indicative rating and is based on best available information.

The Maharashtra-based IPPL was incorporated in 2002 by Dr. D. J Zawar. The company is engaged in manufacturing and market pharmaceutical formulations in the form of tablets and capsules since 2007.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
