Rating Rationale

Acuite has reaffirmed the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 12.00 crore bank facilities of Impulse Pharma Private Limited (IPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The Maharashtra-based Impulse Pharma Private Limited (IPPL) was incorporated in 2002 by Dr. D. J Zawar. The company is engaged in manufacturing and market pharmaceutical formulations in the form of tablets and capsules since 2007.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
