**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** and the short term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 10.00 Cr. bank facilities of Magnum Pigments and Polymers Private Limited (MPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Maharashtra based, MPPL was established in 1991 by Mr. B. Sampath kumar Rai as proprietorship concern named 'Magnum Chemicals'. Further, the constitution has been changed to private limited in 2003. The company is engaged in manufacturing of pigment emulsion, specialty chemicals, and construction chemicals. MPPL has installed capacity of 750 MT per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
