Rating Rationale

Acuite has reaffirmed the long term rating of 'ACUITE C' (read as ACUITE C) on the Rs. 8.50 crore bank facilities of Rohit Trading Company (RTC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Rohit Trading Company (RTC) is a Gujarat-based proprietorship firm incorporated in 1995 by Mr. Haresh Somaiya. The firm is engaged in the trading of agro products such as sugar, jaggery and coriander, etc. Their registered office is in Jamnagar, Gujarat.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
