Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.21 crore bank facilities of Inder Engineering Industries(IEI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Navi Mumbai based Inder Engineering Industries(IEI), a proprietorship concern established in 1976 is engaged in the manufacture of traction control equipment such as contactors, switch gears, relays, among others. The firm, headed by Mr. K.S. Nanda, is an ISO 9001:2008 certified and RDSO (Research Design and Standards Organisation) approved supplier to Indian Railways.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
