Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) and the short-term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs.13.00 Crore bank facilities of RKBK Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Kolkata based RKBK Limited, incorporated in 1976, is an authorized dealer of IOCL. The company deals in petroleum products through 80 depots and 16 petrol pumps in Utter Pradesh, Bihar and Jharkhand. It is also engaged in blending, packaging and selling of tea, tooth paste, detergent powder under the 'Dinkar' brand name. Directors of RKBK Limited are Brijendra Kumar Poddar, Chandra Kumar Kanoria, Krishna Neotia, Yashwardhan Poddar, Ashok Kumar Goel.
