### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus)on the Rs. 7.75 crore bank facilities of Oswal Seeds and Chemicals (OSAC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Oswal Seeds and Chemicals (OSAC), established by Mr. Sanjay Begani and Mr. Anil Nahata in 2002, is engaged in the processing of agricultural seeds at Neemuch (Madhya Pradesh). The firm has an installed capacity of 2,00,000 quintal per annum and sells seeds under the 'Oswal' brand name in Madhya Pradesh, Maharashtra and Bihar.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
