Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 8.85 crore bank facilities of Aligarh Roller Flour Mills Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Kanpur based Aligarh Roller Flour Mills Private Limited was established in 1987 by Mr. Rampal Juneja and Mr. Bankey Lal Agarwal. The company is engaged in the manufacture of food products, including flour, bran, maida, among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
