Rating Rationale

Acuite has reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of S. Jayavel Exim (SJE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Chennai-based, SJE, is a proprietorship firm established in 2005 by Mr. S. Jayavel. The firm is engaged in the grading, repacking and export of agro products (onions, chillies, groundnut, and rice, among others to Singapore, Malaysia and Indonesia).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
