Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) short term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs. 12.00 crore bank facilities of M. M. Constructions. This rating is now an indicative rating and is based on best available information.

MM Construction (MMC), a partnership firm incorporated in 2001 by Mr. Mukesh Hansraj Shah and Mrs. Deepti Jaswantra Shah is engaged in the construction and maintenance of roads. The firm undertakes tender based orders from Municipal Corporation of Greater Mumbai (MCGM).

#### Non-cooperation by the issuer/borrower:
