Acuite has reviewed long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs.14.90 Crore bank facilities of Sri Lakshmi Govardana Rice Industry. This rating is now an indicative rating and is based on best available information.

Sri Lakshmi Govardana Rice Industry (SLGRI), a partnership firm, established in 2013 by Mr. Vinod Naidu and family is engaged in the processing of parboiled rice. The manufacturing facility is located at Nellore, Andhra Pradesh with installed capacity of 16 tons per hour.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
