### **Rating Rationale**

Acuité has revised the long term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs.8.00 crore bank facilities of Shree Metalloys Limited. This rating is now an indicative rating and is based on best available information.

Shree Metalloys Limited (SML), incorporated in 1994, trades in ferrous and non-ferrous metals and undertakes job work for metal alloys wires (zipper wires). These are used in ball pen manufacturing.

**Non-cooperation by the issuer/borrower:** Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
