### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus)on the Rs. 6.00 crore bank facilities of Ambica Iron & Steel Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Ambica Iron & Steel Private Limited (AISPL), established in 1983, commenced commercial production from 1985 to manufacture structured steel. The products include rounds, angles, channels, among others. Promoted by Mr. Sanjay Kumar Bansal and family, the company has an installed capacity of 1,800 tons per annum. The manufacturing facilities are located at Rourkela, Orissa.

### **Unsupported Rating**

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
