Acuité has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.5.13 crore bank facilities of BN Precast Private Limited (BNPPL). This rating is now an indicative rating and is based on best available information.

BNPPL was incorporated on 23 January, 2013. It is engaged in manufacturing of precast structures. It is promoted by Mr. Nishant Subhash Patel and Mr. Bhumi Nishant Patel and the manufacturing unit is located in Ahmedabad (Gujarat). For FY2016-17, BNPPL reported a PAT of Rs.0.25 crore on operating income of Rs.5.06 crore as against PAT of Rs.2.25 crore on operating income of Rs.7.77 crore for FY2015-16. The net worth stood at Rs.3.46 crore as on March 31, 2017 against Rs.3.22 crore a year earlier.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
