**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 5.13 crore bank facilities of BN Precast Private Limited (BNPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

BNPPL was incorporated on 23 January, 2013. It is engaged in manufacturing of precast structures. It is promoted by Mr. Nishant Subhash Patel and Mr. Bhumi Nishant Patel and the manufacturing unit is located in Ahmedabad (Gujarat).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
