Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE Double B Minus)** on the Rs.11.00 Crore bank facilities of Shree Garodi Steels (SGS). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Mangalore based Shree Garodi Steels (SGS) was established in the year 2011 as partnership firm by Mr. Manoj Kumar and Mr. Siddarth Jain. It is an authorized distributor for APL Apollo and Apple Gold steel for TMT Bar in Mangalore and Dakshina Kannada district of Karnataka since 2015. It is also engaged in dealership of different steel manufacturing companies like Tata Steel and JSW Steel mainly for TMT Bar and other structural products like pipes, tubes, angles and plates, etc.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
