Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.50 crore bank facilities of Chien Hsing Tannery (CHT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

CHT was established in 2007 as a partnership firm by Mr. Naresh Kumar Juneja and Ms. Minnie Juneja. The firm is engaged in manufacturing of finished leather with the total capacity of 12 Lakh Square Feet/Month. The firm has a manufacturing unit located in West Bengal and the firm procures 80 per cent of its major raw material i.e. raw leather and chemicals from local market of Kolkata. The other 20 per cent, they procure from the market of Mumbai and Kanpur.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
