SMERA has reviewed long-term rating of '**SMERA D' (read as SMERA D)** on the Rs. 6.82 crore bank facilities of Sm Consumers Private Limited. This rating is now an indicative rating and is based on best available information.

About the Rated Entity

SM Consumers Private Limited (SMCPL) manufactures juices and pickles under the 'Freshy' brand name at Assam. The company commenced commercial operations in 2013 under the directorship of Mr. Bikash Goduka and Mr. Raj Kumar Goduka.

For FY2014-15 (refers to financial year April 01 to March 31), SMCPL reported net profit of Rs.0.32 crore on operating income of Rs.10.57 crore, compared with profit after tax (PAT) of Rs.0.25 crore on operating income of Rs.7.64 crore in FY2013-14.
