### **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D)on the Rs. 6.82 crore bank facilities of SM Consumers Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### Non-cooperation by the issuer/borrower:
