


## Rajasthan Digital Tiles Private Limited August 11, 2023





## **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and short term rating to 'ACUITE A4' (read as ACUITE A four) on the Rs. 11.50 crore bank facilities of Rajasthan Digital Tiles Private Limited (RDTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Rajasthan Digital Tiles Private Limited was established in 2013 at Jaipur (Rajasthan) by Mr. Virendra Pal Singh, Mr. Rajeev Bahuguna and Mr. Nawal Singh. The company is engaged in manufacturing of ceramic tiles and digital tiles. The manufacturing facility is located in Rajasthan with an installed capacity of 8,000 boxes tiles per day and utilises around 100 percent of its capacity

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity / industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
