#### Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE D**' (**read as ACUITE D**) and the short-term rating of '**ACUITE D**' (**read as ACUITE D**) on the Rs.26.00 Cr bank facilities of Doctor Pack India Private Limited. The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating continues to be an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Doctor Pack India Private Limited, incorporated in 2010, is a Bangalore-based company promoted by Mr. Umapathi Raju, Mr. Jatinkumar Pandiya and Mr. G. Dinakaran. The company is engaged in the manufacture of packaging products for the pharmaceutical industry. The company has a facility located in Bangalore, Karnataka.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
